**TENDER NO. 88-25, OPERATION OF CITY EXCESS SOIL REUSE SITE**

**Electronic bid submissions shall be accepted and received by the City on or before the Submission Deadline of MONDAY, JUNE 2<sup>nd</sup>, 2025, at Eleven-Thirty Fifty-Nine (11:30:59) a.m. (E.D.T) through the City's Bidding System: [www.biddingo.com/windsor](http://www.biddingo.com/windsor) to provide general contracting services, including:**

- Reuse Site access improvements (e.g. culverts, fencing modifications),
- Topsoil stripping and erosion and sediment control measures,
- Construct a laydown yard to receive excess soil and granular stone deliveries,
- Manage excess soils as they are delivered to the reuse site, including direct placement within proposed right-of-way, or stockpiling within laydown yard and/or future leased land properties,
- Placement and maintenance of excess soils to meet/exceed ERCA minimum flood proof elevations within the employment land lots, including build-up of proposed roadways and stockpile for future leased lands.
- Supply, placement and maintenance of granular materials for the proposed roadways for the Airport Employment Lands, and,
- All as shown on the contract drawings and described hereinafter or as may otherwise be directed by the Engineer for the City of Windsor.

A Bid submitted by mail, in person, fax, e-mail or other electronic means, other than through the Bidding System: [www.biddingo.com/windsor](http://www.biddingo.com/windsor), will not be accepted.
