This addendum amends and forms part of the Tender Documents. The bidder shall insert the addendum behind the cover page of the Tender Documents.

QUESTIONS AND ANSWERS

- 1. When selecting Cyclones is it 2x / side? Should the tanks be Joined? **Answer:** Yes, 2x / side and yes, the tanks should be joined.
- 2. Would the City agree to a one-week extension setting the deadline to: Monday December 15Th? Answer: No.
- 3. Cummins ISL370 is not legal for use in Canada as it does not comply with the latest emission regulations of Transport Canada. Would the city accept a Cummins X-12, 370 HP? Answer: Yes.
- 4. 10 yards vs 9 yards debris tank +1,000 us gallons of water; 10 Yards debris tank can be offered but represents the high limit for a single axle chassis and runs a chance to be overweight faster (less payload). Would the city be open to review a 9 yards debris tank which would offer a better loading/capacity ratio or should the 10 yard be a set requirement?

Answer: No.

5. Effective vs Usable water capacities (rodder vs triplex); Unit stated capacity of 0-80 GPM at variable pressure up to 2500 PSI is requested. Is it agreed that Vac-Con selection of a Triplex 80 GPM @ 2500 PSI pump complies with the City water pump spelled requirements?

Answer: No.

Except for the contents of this addendum, all other terms and conditions of this request for tender remain the same.
