TENDER NO. 16-23, 2023 ROAD REHABILITATION – LAUZON PARKWAY PHASE 2

Electronic bid submissions only, shall be accepted and received by the City on or before the Submission Deadline of FRIDAY, MARCH 17TH, 2023, at Eleven-Thirty Fifty-Nine (11:30:59) a.m. (E.D.T) through the City's Bidding System: www.biddingo.com/windsor, for:

- Reconstruction of the existing concrete roadway along Lauzon Parkway from Cantelon Drive to asphalt match south of Forest Glade Drive.
- Road work does not include the intersection of Cantelon Drive.
- Remove concrete, fine grade, trench in subdrain and place OGDL
- Any and all catchbasin installations including coring/taping into existing storm sewer.
- The proposed pavement structure will be 250mm concrete pavement on 100mm OGDL
- Remove and reinstall multi-use trail (in asphalt)
- Streetlight improvements on east side and Traffic infrastructure work at the Forest Glade and Essex Way intersections

A MANDATORY site visit will be held on THURSDAY, MARCH 9TH, 2023, at 10:00 a.m. (E.S.T.), at 7515 Forest Glade Drive, Windsor, Ontario (Parking lot at the South East corner of Lauzon and Forest Glade). Attendees are required to wear hardhat, safety vest and safety footwear.

Tender documents are available for download, upon payment of a non-refundable fee at Biddingo, www.biddingo.com/windsor. A Bid submitted by mail, in person, fax, e-mail or other electronic means, other than through the Bidding System: www.biddingo.com/windsor, will not be accepted.
