Electronic bid submissions only, shall be accepted and received by the City on or before the Submission Deadline of WEDNESDAY, JANUARY 25<sup>TH</sup>, 2023, at Eleven-Thirty Fifty-Nine (11:30:59) a.m. (E.S.T) through the City's Bidding System: <a href="www.biddingo.com/windsor">www.biddingo.com/windsor</a>, for the furnishing of all labour, equipment, supervisions, plant, and materials necessary to carry out the following: Cabana Corridor Improvements Phase 4 – Highway 3 to Mount Carmel Drive;

- a. The construction of a new storm and sanitary sewer and private drain connections including the removal/grouting of the existing sewer system and manholes.
- b. Excavation and grading.
- c. New conduit and streetlighting.
- d. Placement and compaction of fill materials.
- e. Installation of concrete curbs and asphalt pavement.
- f. Sidewalk reconstruction and boulevard restoration.
- g. All as shown on the contract drawings and described hereinafter, or as may otherwise be directed by the Engineer for the City of Windsor.
