Electronic bid submissions only, from the prequalified contractors, listed below shall be accepted and received by the City on or before the Submission Deadline of <u>THURSDAY</u>, <u>MARCH 20<sup>TH</sup>, 2025</u>, at Eleven-Thirty Fifty-Nine (11:30:59) a.m. (E.D.T) through the City's Bidding System: <u>www.biddingo.com/windsor</u>, for construction of a new interchange and underpass at the intersection of Banwell Road and E. C. Row Expressway and widening and associated infrastructure improvements of Banwell Road from Mulberry Drive south to the City limits including the Canadian Pacific Kansas City railway crossing.
